

# **NOTICE OF A HEARING**

Enbridge Gas Inc. has applied to construct natural gas pipelines in the Town of East Gwillimbury and potentially in the Township of King, Town of Georgina, and Town of Whitchurch-Stouffville


## **Enbridge Gas Inc. (the applicant) has applied for approval:**

- To Construct pipelines needed to supply natural gas to approximately 369 forecasted customers located in the Towns of East Gwillimbury, Georgina, and Whitchurch-Stouffville and Township of King.
- To Install nine pipeline sections organized in two construction phases:
- o Phase 1: Approximately 80 m of 4-inch polyethylene (PE) distribution pipeline, and approximately 8.5 km of 2-inch PE distribution pipeline and ancillary facilities.
- o Phase 2: Approximately 10.1 km of 4-inch PE distribution pipeline, approximately 18.5 km of 2-inch PE distribution pipeline, approximately 60 m of 4-inch steel distribution pipeline, approximately 115 m of 2-inch steel distribution pipeline and ancillary facilities.
- Of the forms of agreement it will offer to landowners affected by the routing or location of the proposed pipelines.

Enbridge Gas has also requested orders cancelling and superseding certain of its existing Certificates of Public Convenience and Necessity with new certificates that address changes in municipal names and boundaries.

The project was approved to receive funding assistance under Phase 2 of the Government of Ontario's Natural Gas Expansion Program.

The OEB will also assess:

- The applicant's compliance with the OEB's Environmental Guidelines for the Location, Construction and Operation of Hydrocarbon Pipelines and Facilities in Ontario.
- Whether the duty to consult with Indigenous Communities potentially affected by the proposed pipeline has been discharged with respect to the application.

## THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

There are three types of OEB Hearings: oral, electronic and written. The applicant has applied for a written hearing. If you think a different hearing type is needed, you can write to us to explain why. During this hearing, we will question the applicant about its case. We will also hear questions and arguments from participants that have registered as Intervenors. After reviewing all the evidence, we will decide whether to approve this application.
