# Invitation to Bid -Enbridge Gas Inc. Binding Existing Capacity Open Season C1 Transportation

Enbridge Gas Inc. ("**Enbridge Gas**") is holding an open season for firm C1 transportation service for 11,970 GJ/d of Dawn to Dawn-Vector existing capacity beginning May 1, 2024 for a minimum one (1) year term ("**Open Season**").

All bids are due on or before 2 p.m. ET/ 1 p.m. CT, on April 26, 2024. Enbridge Gas expects to award capacity on or before 4 p.m. ET/ 3 p.m. CT on April 26, 2024.

### Submitting a Bid for Service and awarding capacity

Enbridge Gas, at its sole discretion, reserves the right to reject any and all proposals received, terminate the Open Season, or modify or extend the Open Season or related documents.

All capacity requests that meet the respective service parameters during this Open Season will be awarded as per Enbridge Gas' Allocation Procedures in Section XVI of the Enbridge Gas C1 tariff <u>General Terms and Conditions</u>, starting with those bids with the highest economic value. If the economic values of two or more independent bids are equal, then service shall be allocated on a pro-rata basis.

The economic value shall be based on the net present value which shall be calculated based on the proposed per unit rate and the proposed term of the contract and without regard to the proposed contract demand.

Any suggested conditions precedent proposed by the bidder should be clearly articulated and attached to the bid form and will be considered during the capacity allocation process.

All bids are due on or before 2 p.m. ET/ 1 p.m. CT, on April 26, 2024. Enbridge Gas expects to award capacity on or before 4 p.m. ET/ 3 p.m. CT on April 26, 2024.

Any party wishing to submit a bid for C1 transportation service should submit a completed Bid Form under the above terms and conditions by email indicating the Quantity and Term of the bid, as well as if the bid is subject to any conditions precedent, in addition to the standard preconditions in Section XXI of the Enbridge Gas C1 tariff General Terms and Conditions.

#### About the Enbridge Gas Dawn Hub

The Enbridge Gas Dawn Hub is the largest integrated natural gas storage facility in Canada and one of the largest in North America. It offers customers, such as power generators, distribution and pipeline companies and energy marketers, an important link in the movement of natural gas from key supply basins to markets in central Canada and the northeast U.S.



- A working storage capacity of approximately 288 Bcf.
- Bi-directional service.
- Takeaway capacity of more than 7.5 Bcf a day.

If Bidder does not execute the C1 Contract within 30 days of delivery by Enbridge Gas of written notice to Bidder, Enbridge Gas may, in its sole discretion, elect by written notice to Bidder within 15 days thereafter, to either terminate Bidder's participation in this Open Season, or treat Bidder's signature and return of this Bid Form together with the C1 Contract as the legally binding agreement (modified as applicable by Enbridge Gas' notification of the quantities allocated to Bidder) between Bidder and Enbridge Gas for the firm transportation services outlined above. Bidder acknowledges and agrees that any transportation service provided by Enbridge Gas prior to execution by Bidder of the C1 Contract shall be subject to the terms and conditions set forth in this Bid Form and the C1 Contract. In the event of any inconsistency or conflict between the terms and conditions of this Bid Form and the C1 Contract, this Bid Form shall prevail to the extent of any inconsistency.
