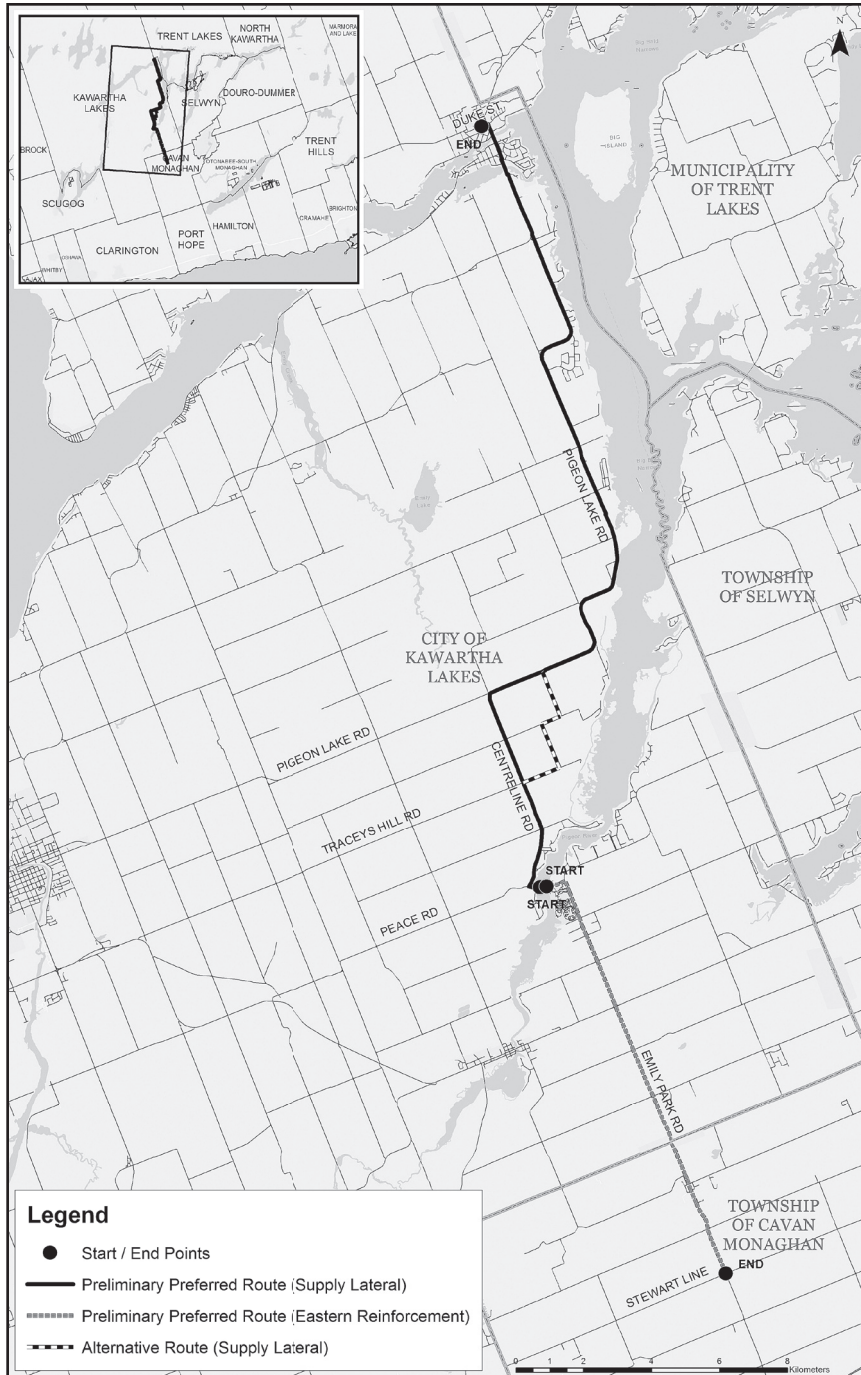


## Enbridge Gas Inc. has applied for approval to construct natural gas pipelines and ancillary facilities in the City of Kawartha Lakes (including Bobcaygeon) and Township of Cavan-Monaghan.

Enbridge Gas Inc. has applied to the Ontario Energy Board for approval to construct the Bobcaygeon Community Expansion Project which involves the construction of:

- (i) A Supply Lateral, through the City of Kawartha Lakes to Bobcaygeon consisting of:
  - 25 kilometres of 6-inch extra high pressure steel natural gas distribution pipeline
  - 2 kilometres of 6-inch high pressure polyethylene natural gas distribution pipeline
  - 1 kilometre of 6-inch high pressure steel natural gas distribution pipeline
- (ii) An Eastern Reinforcement Pipeline, running from Enbridge Gas's existing system within the Township of Cavan-Monaghan into the City of Kawartha Lakes, comprising 13 km of 6-inch extra high pressure steel natural gas distribution pipeline.

The general location of the Bobcaygeon Community Expansion Project is shown in the map.

Enbridge Gas Inc. has also applied for approval of the forms of agreements that it has offered or will offer to landowners affected by the routing or location of the pipelines.

Enbridge Gas Inc. states that the pipelines are needed to supply natural gas to approximately 4,000 new customers in the community of the City of Kawartha Lakes (including Bobcaygeon) who currently do not have access to natural gas service. Enbridge Gas intends to charge the OEB-approved System Expansion Surcharge to all new customers taking service from the project.

Enbridge Gas Inc. states that the Bobcaygeon Community Expansion Project has been approved to receive funding assistance under Phase 2 of the Government of Ontario's Natural Gas Expansion Program.

#### THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Enbridge Gas's application. During the hearing, which could be an oral or written hearing, we will question Enbridge Gas on the case. We will also hear questions and arguments from individual consumers, municipalities and others whose interests would be affected. At the end of this hearing, the OEB will decide whether to approve the application.

As part of its review of this application, the OEB will assess Enbridge Gas's compliance with the OEB's *Environmental Guidelines for the Location, Construction and Operation of Hydrocarbon Pipelines and Facilities in Ontario*.

#### The OEB will also assess whether the duty to consult with Indigenous Communities potentially affected by the proposed pipeline has been discharged with respect to the application.

There are two types of OEB hearings – oral and written. Enbridge Gas has applied for a written hearing. The OEB is considering this request. If you think an oral hearing is needed, you can write to the OEB to explain why by **June 20, 2022**.
