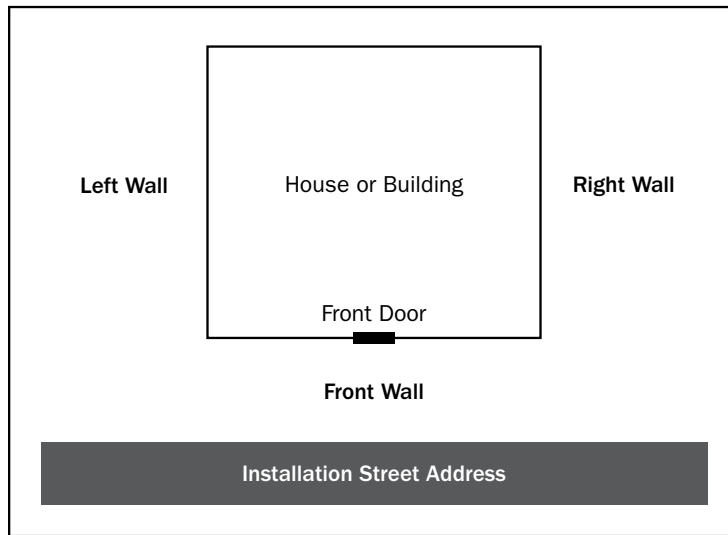

In situations where it has been determined a contribution is required towards the installation of the service, the property owner will be notified and must formally agree to the associated costs before Enbridge can process the application.
