# New natural gas rates

The Ontario Energy Board (OEB) has approved changes to Enbridge Gas' rates effective April 1, 2024.

The total impact on your bill will depend on how much gas you use and the terms of your gas marketer agreement.

#### **Delivery to You**

The delivery rates that vary with consumption decreased based on our forecast cost of delivering natural gas to your home or business. These charges also include a facility carbon charge associated with the operation of Enbridge Gas' facilities to deliver natural gas to you. The facility carbon charge has decreased from 0.0157 cents per cubic metre ( $\phi/m^3$ ) to 0.0143  $\phi/m^3$ .

#### **Transportation to Enbridge**

The transportation charge has decreased by approximately \$14.60 per year for a typical customer due to lower costs for transporting natural gas to Ontario.

# **Federal Carbon Charge**

The federal carbon charge has increased from 12.39  $\phi/m^3$  to 15.25  $\phi/m^3$ . This charge increases annually each April. All of the money collected for this charge goes to the government.

#### **Gas Supply Charge**

The price you pay for the natural gas you use, shown as the gas supply charge on your bill, depends on the terms of your gas marketer agreement.

# **Cost Adjustment**

The current adjustment is a charge of 0.3778 ¢/m<sup>3</sup>. The cost adjustment reflects the true-up between actual and forecast prices for prior periods. Please see the included chart for the breakdown by component.

# **Rate Adjustment**

The OEB has approved a rate adjustment to reflect the clearance of 2022 deferral and variance account balances. This will appear as a one-time adjustment on customers' April bills, and for a typical customer this will be a charge of approximately \$43.34.

The OEB has approved a rate adjustment to reflect the clearance of 2022 federal carbon deferral and variance account balances. This will appear as a one-time adjustment on customers' April bills, and for a typical customer this will be a charge of approximately \$7.25.

Charges for gas used from April 1, 2024 will be calculated using the new approved rates as shown in the chart. The annualized impact is based on a typical Rate 10 - Union North West customer who uses 93,000 m<sup>3</sup> per year while buying gas from an energy marketer.
