Unless the Company specifically provides written authorization to exceed contract parameters, any excess shall be unauthorized overrun and shall incur charges as referenced in the Rate Schedule.

Seasonal Contract Demand is a Firm Service available for the period April 1 to October 31.

The total Contract Demand (CD) is the sum of the Firm Contract Demand, Seasonal Contract Demand and Interruptible Contract Demand (hereinafter called the "Contract Demand").

The Interruptible Contract Demand shall be subject to interruption by the Company on not more than \_\_\_\_\_ days in any Contract Year. The Company shall provide Customer at least \_\_\_\_\_ hours notice before interrupting this service.

**3 RATES FOR SERVICE**

- (i) All charges will be as specified in the M7 rate schedule.
- (ii) For interruptible service, the Monthly Interruptible Delivery Commodity Charge is \_\_\_\_\_ per m<sup>3</sup>.
- (iii) On any Day, any Gas in excess of one hundred and three percent, (103%), of the Contract Demand shall be unauthorized overrun gas and shall be paid for at the rate specified in the Rate Schedule.
- (iv) On any Day during the Contract Year Gas usage shall be deemed as follows:
  - First gas used            Firm Gas up to the Firm Contract Demand then in effect.
  - Next gas used            Seasonal Gas (if applicable)

Next gas used                      Interruptible Gas (if applicable) up to the Interruptible Contract Demand then in effect.

Overrun gas                         As specified in this Section
