

4 benefits of make-up air unit upgrades Affordable multi-family housing buildings typically need to replenish a large volume of air on a frequent basis—

and because of the temperature difference between indoor and outdoor air, make-up air (MUA) units tasked with air replenishment can account for a significant portion of an HVAC system's overall energy use.

Upgrading to condensing MUA units can contribute to improved building air quality, lower energy bills and



1. Improve air quality Condensing MUA units bring in fresh, outdoor air by replenishing the air pushed out through exhaust

systems more efficiently, reducing contaminants and improving indoor air quality.

2. Lower energy bills

Because they offer added insulation and condensing technology with multiple heat exchangers,

condensing MUA units are a more energy-efficient alternative to standard MUA units. As a result, condensing MUA units use less natural gas to operate, which saves on ongoing energy costs.

3. Enhance comfort Well-performing MUA units efficiently replace air, and prevent unbalanced heating and cooling conditions that force residents to use windows and doors to correct imbalances.


