Enbridge Gas Distribution Inc.

**Application for leave to construct a natural gas pipeline and associated facilities
in the Liberty Village area of the City of Toronto**

PROCEDURAL ORDER NO. 1

August 24, 2018

On June 14, 2018¹, Enbridge Gas Distribution Inc. (Enbridge Gas) applied to the Ontario Energy Board (OEB) under sections 90(1) and 97 of the *Ontario Energy Board Act, 1998* for approval to construct approximately 1.2 kilometres of natural gas pipeline in the in the Liberty Village area of the City of Toronto and of the form of land use agreements it offers to landowners to use their lands for construction of the proposed pipeline.

The OEB issued a Notice of Hearing on August 1, 2018. The OEB did not receive any requests for intervenor status.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. OEB staff shall request any information and material from Enbridge Gas that is in addition to Enbridge Gas' evidence and that is relevant to the hearing by written interrogatories filed with the OEB and delivered to Enbridge Gas by **August 29, 2018**.
2. Enbridge Gas shall file with the OEB complete written responses to all interrogatories by **September 5, 2018**.

¹ Enbridge Gas' original application was filed on April 6, 2018. The application was placed in abeyance by the OEB after Enbridge Gas informed the OEB that it wished to update its application to include an updated Environmental Report to account for an 85 metre segment of the proposed pipeline that had been missed in the original filing. The update was filed on June 14, 2018. On July 16, 2018 Enbridge Gas amended its June 14, 2018 filing to include a request for approval of the form of land use agreements.

3. Unless the OEB orders otherwise, OEB staff may file a written submission with the OEB and deliver it to Enbridge Gas by **September 12, 2018**.
4. Unless the OEB orders otherwise, Enbridge Gas may file a written reply submission with the OEB by **September 19, 2018**.

All filings to the Board must quote the file number, EB-2018-0096 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <https://www.oeb.ca/industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
