**AND IN THE MATTER OF** an application by Union Gas Limited for: an Order or Orders for pre-approval of recovery of the cost consequences of all facilities associated with the development of the proposed Parkway West site; an Order or Orders granting leave to construct natural gas pipelines and ancillary facilities in the Town of Milton; an Order or Orders for pre-approval of recovery of the cost consequences of all facilities associated with the development of the proposed Brantford-Kirkwall/Parkway D Compressor Station project; an Order or Orders for pre-approval of the cost consequences of two long term short haul transportation contracts; and an Order or Orders granting leave to construct natural gas pipelines and ancillary facilities in the City of Cambridge and City of Hamilton.

#### **PROCEDURAL ORDER NO. 4**

The Ontario Energy Board has received three related applications requesting approval for the Applicants to undertake system expansion projects: one filed by Enbridge Gas Distribution Inc. (“Enbridge”) and two filed by Union Gas Limited (“Union”).

---

A record of all procedural matters that have been dealt with up to this point in this combined proceeding is available on the Board's web site.

On, June 27, 2013 TransCanada Pipelines Ltd. ("TCPL") requested that the Board adjust the proceeding's schedule related to TCPL's intervenor evidence due to the severe flooding that has taken place in Calgary. Gaz Metro Limited Partnership ("Gaz Metro") further requested that out of fairness, all intervenors be granted the same extension TCPL receives so that all intervenor evidence is received at the same time. Gaz Metro did not provide any reasons to substantiate why an extension for all intervenor evidence is warranted to ensure fairness.

The Board grants TCPL's request for an extension to file its intervenor evidence and has adjusted the dates for interrogatories and interrogatory responses on TCPL's evidence accordingly. The Board will not grant Gaz Metro's request because no substantive justification was provided. The subsequent procedural changes are noted below and reflected in the case timetable at Appendix A.

The Board considers it necessary to make provisions for the following matters related to this proceeding. The Board may issue further procedural orders from time to time.

**THE BOARD ORDERS THAT:**

1. If TCPL intends to file evidence, it shall do so on or before **Friday, July 5, 2013**.
2. Parties and Board Staff wishing to seek further information from the TCPL on its evidence shall request it by written interrogatories filed with the Board and served on all parties on or before **Friday, July 12, 2013**.
3. TCPL shall file complete responses to all interrogatories and serve them on all parties on or before **Friday, July 19, 2013**.

All filings to the Board must quote the file number, EB-2012-0451/EB-2012-0433/EB-2013-0074, be made through the Board's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format.
