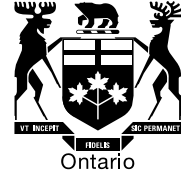

**LETTER OF DIRECTION**  
**NOTICE OF REVISED APPLICATION**

Dear Ms. Spratt:

**Re: Enbridge Gas Distribution Inc.  
Greater Toronto Area Project  
Board File Number EB-2012-0451**

The Ontario Energy Board has now issued its Notice of Revised Application (“Notice”) relating to your Leave to Construct application. Please note that you must publish the notice within fourteen (14) days of the date of this letter. If publication is impossible within this timeframe, you must inform the Board staff contact given at the bottom of this letter immediately.

You are directed:

1. To conduct a search of title forthwith, sufficient to determine the current registered property owners and encumbrancers with lands or interest in the lands directly affected by the **revised section of Segment A** of the proposed pipeline;
2. To immediately serve a copy of the Notice including the location map, together with a copy of the relevant application, either personally, by courier, or by registered mail, upon all property owners and encumbrancers with lands or interest in lands

identified in the search of title referred to in No. 1 above. If a party does not provide a mailing address for service, or states a preference for e-mail service, the service may be done via e-mail;

3. To immediately serve a copy of the Notice of Revised Application, including a copy of the relevant application, either personally, by courier, or by registered mail, upon all registered Intervenor in EB-2012-0451 proceeding, upon the clerks of the affected municipalities, upon all affected First Nations and First Nation communities. If a party does not provide a mailing address for service, or states a preference for e-mail service, the service may be done via e-mail;
4. To immediately arrange for the English version of the Notice, headed with the Ontario Government logo and the words "Ontario Energy Board", to be published in one issue of the English language daily newspaper and one issue of the English language weekly newspaper having the highest circulation, according to the best information available, in each of Enbridge's service areas;

Please note that invoices regarding publication are not to be sent to the Board;

5. To immediately arrange for the French version of the Notice, headed with the Ontario Government logo and the words "Commission de l'énergie de l'Ontario", to be published in one issue of any French daily newspaper, if available, and one issue of all weekly French language newspapers in each of Enbridge's service areas;

Please note that invoices regarding publication are not to be sent to the Board;

6. To file with the Board affidavit evidence proving the above service and publication immediately upon completion, attaching as appendices the relevant Notice, Application, and original post office registration or courier receipts, but not the newspaper tear sheets;
7. To make a copy of the Application and evidence, and any amendments thereto, available for public review at Enbridge Gas Distribution Inc.'s office and on its website;
8. To make a copy of the Notice available for public review at Enbridge Gas Distribution Inc.'s office and on its website; and,

9. To provide a copy of the Application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
