

## Authorization Form for Acceptance of Online Temporary Transportation Assignments

Enbridge Gas Inc. ("**Enbridge**") and certain shippers ("**Assignors**") have entered into one or more M12 and/or C1 firm gas transportation services contract(s) regarding firm transportation services on Enbridge's gas pipeline system (each such contract a "**Transportation Contract**");

Assignors intend to temporarily assign, through Enbridge's *Enerline* system, from time to time, all or some of the Contract Demand pursuant to a Transportation Contract to other parties (each such party an "Assignee" and each such assignment, an "Online Temporary Assignment") and each Assignee has agreed to accept such Online Temporary Assignment pursuant to the terms of Enbridge's Master Temporary Transportation Assignment Notice;

Assignors and Assignees request that Enbridge permit such Online Temporary Assignment(s) and facilitate the same on the terms and the conditions set out below;

Assignor(s) and Assignee have previously communicated and agreed upon the term and the assigned quantity of the Online Temporary Assignment pursuant to the terms of Enbridge's Online Master Temporary Transportation Assignment Notice;

By entering all required information concerning an Online Temporary Assignment electronically into Enbridge's *Enerline* application, Assignor will have provided Enbridge a notice of a request for an Online Temporary Assignment to Assignee (such request a "**Temporary Assignment Request**"); and

Each Temporary Assignment Request contains the following:

- i) Assignee name;
- ii) the requested term of Online Temporary Assignment, which request shall be submitted prior to the Assignment Deadline (a determined amount of time prior to the start of the Timely Nomination Cycle (1:30pm CCT) for gas flow for the 1st of each month as noted on *Enerline* and as updated from time to time on *Enerline*); and
- iii) Assigned Quantity: the applicable quantity of the Contract Demand to be temporarily assigned to Assignee pursuant to the selected Transportation Contract.
