**Invitation to Bid -

Enbridge Gas Inc. (“**Enbridge Gas**”) is holding an open season for standard Rate 332 transportation service for 10,000 GJ/d of Parkway to Albion existing capacity beginning Nov.1, 2022 for a minimum one (1) year term (“**Open Season**”).

All bids are due on or before 2 p.m. ET/ 1 p.m. CT, on April 8, 2022. Enbridge Gas expects to award capacity on or before 4 p.m. ET/ 3 p.m. CT on April 8, 2022.

Submitting a Bid for Service and awarding capacity

Enbridge Gas, at its sole discretion, reserves the right to reject any and all proposals received, terminate the Open Season, or modify or extend the Open Season or related documents. All capacity requests that meet the respective service parameters during this Open Season will be awarded as per Enbridge Gas’ Capacity Allocation in Section 4 of the Enbridge Gas Rate 332 Tariff FT Service Schedule, starting with those bids with the highest economic value.

If the economic values of two or more independent bids are equal, then service shall be allocated on a pro-rata basis. The economic value shall be based on the net present value which shall be calculated based on the proposed per unit rate and the proposed term of the contract and without regard to the proposed contract demand.

Any suggested conditions precedent proposed by the bidder should be clearly articulated and will be considered during the capacity allocation process.

All bids are due on or before 2 p.m. ET/ 1 p.m. CT, on April 8, 2022. Enbridge Gas expects to award capacity on or before 4 p.m. ET/ 3 p.m. CT on April 8, 2022.

Any party wishing to submit a bid for Rate 332 service should submit a completed Bid Form under the above terms and conditions by email indicating the Quantity and Term of the bid, as well as if the bid is subject to any conditions precedent, in addition to the standard preconditions in Section 2.3 of the Rate 332 Tariff FT Service Schedule.

Service Applicant agrees, by submitting this Bid Form, to abide by the terms and conditions of (a) the Tariff for Rate 332 Service, including the applicable Service Schedule, the General Terms and Conditions, and the applicable Service Agreement (per the standard form); and (b) the Rate 332 Schedule.

About the Enbridge Gas Dawn Hub

The Enbridge Gas Dawn Hub is the largest integrated natural gas storage facility in Canada and one of the largest in North America. It offers customers, such as power generators, distribution and pipeline companies and energy marketers, an important link in the movement of natural gas from key supply basins to markets in central Canada and the northeast U.S.
