Invitation to Bid Enbridge Gas Inc. Binding Existing Capacity Open Season C1 Transportation

Enbridge Gas Inc. ("**Enbridge Gas**") is holding a binding open season for C1 firm transportation service for existing capacity beginning as early as Nov.1, 2022 for a minimum one (1) year term ("**Open Season**") along the following transportation paths:

- (a) Dawn to Parkway
- (b) Kirkwall to Parkway
- (c) Kirkwall to Dawn
- (d) Parkway to Dawn

All bids are due on or before 2 p.m. ET/ 1 p.m. CT, on Oct. 20, 2022. Enbridge Gas expects to award capacity on or before 4 p.m. ET/ 3 p.m. CT on Oct. 20, 2022.

Submitting a Bid for Service and Awarding of Capacity

Enbridge Gas, at its sole discretion, reserves the right to reject any and all bids received, terminate the Open Season, or modify or extend the Open Season or any related documents. All bids for capacity that meet the respective service parameters during this Open Season will be awarded as per Section 16 – Allocation of Capacity of the Enbridge Gas Rate C1 General Terms and Conditions, starting with those bids with the highest economic value.

If the economic values of two or more independent bids are equal, then service shall be allocated on a pro-rata basis. The economic value shall be based on the net present value which shall be calculated based on the proposed per unit rate and the proposed term of the contract and without regard to the proposed contract demand.

Any suggested conditions precedent proposed by the bidder should be clearly articulated and will be considered during the capacity allocation process.

All bids are due on or before 2 p.m. ET/ 1 p.m. CT, on Oct. 20, 2022. Enbridge Gas expects to award capacity on or before 4 p.m. ET/ 3 p.m. CT on Oct. 20, 2022.

Any party wishing to submit a bid for C1 service should provide a bid under the above terms and conditions by email indicating the Quantity and Term of the bid, as well as if the bid is subject to any conditions precedent in addition to the standard preconditions in Section XXI of Schedule "A 2010" Rate C1 General Terms and Conditions.

About the Enbridge Gas Dawn Hub

The Enbridge Gas Dawn Hub is the largest integrated natural gas storage facility in Canada and one of the largest in North America. It offers customers, such as power generators, distribution and pipeline companies and energy marketers, an important link in the movement of natural gas from key supply basins to markets in central Canada and the northeast U.S.



- A working storage capacity of approximately 280 Bcf.
- Bi-directional service.
- Takeaway capacity of more than 8 Bcf a day.
- Daily demand at Dawn from markets in Ontario, Quebec, the U.S. Midwest and the U.S. Northeast.
