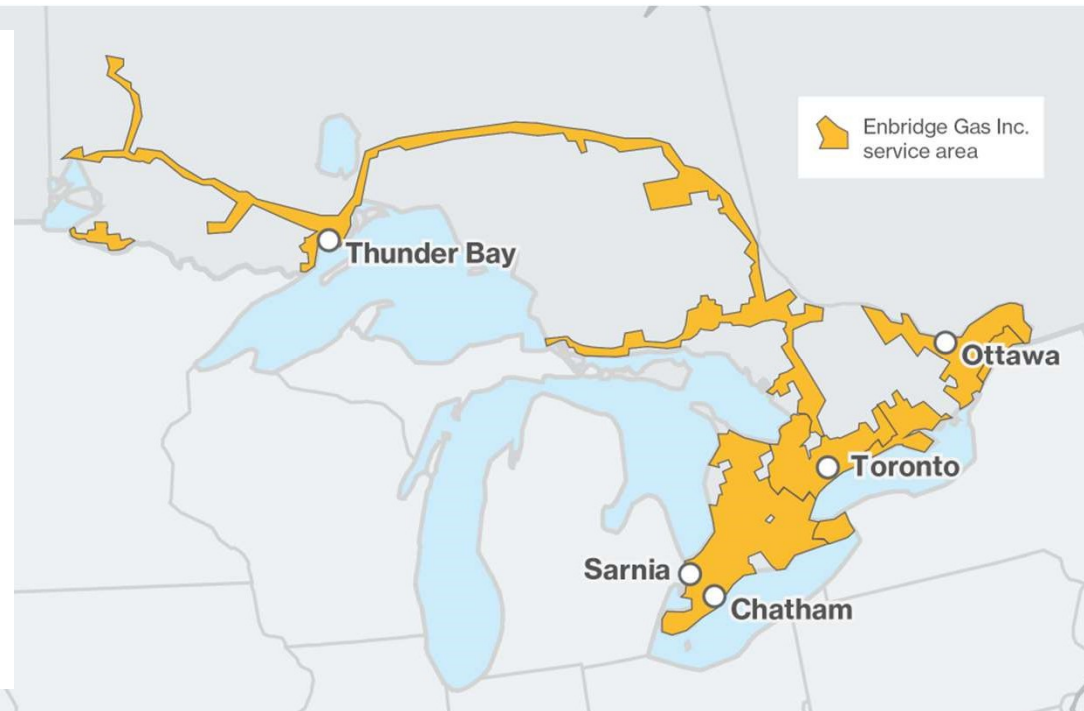

# Purpose



- Enbridge Gas Inc. is soliciting proposals for storage services.
  - Traditional “year-round” storage and products offering reduced flexibility will be considered
  - The submission of multiple offers with varying term length and parameter flexibility is encouraged

# Injections and withdrawals



- Location: Dawn
  - Provide details of any transportation capacity included as part of the storage offering to facilitate Dawn injections and withdrawals
- Minimum Injection/Withdrawal Rights
  - Firm injection period must include months of May 1 through Sept. 30
  - Firm withdrawal period must include months of Dec. 31 through to March 31

## Service term length



- Up to five (5) years commencing April 1, 2021
- Enbridge Gas is seeking service offerings of various term lengths

Term	Potential To Be Contracted
1 year	0 PJs
2 years	0 – 1 PJs
3 years	0 – 2 PJs
4 years	0 – 2 PJs
5 years	0 – 3 PJs

## How to submit a bid

- Complete bid template provided by Guidehouse Consulting
  - Bids not submitted using template are considered to be non-conforming
  - Note that bids are to be submitted in CAD/GJ
  - Multiple offers are encouraged
- Provide sample invoice calculations for each submission
  - Sample injection month and withdrawal month
- Completed bid templates and sample invoice calculations are to be submitted to the RFP manager

- This is a blind RFP
  - Do not submit bids, ask questions or contact anyone at Enbridge Gas to discuss this RFP
- Bid deadline: 2 p.m. Mountain Daylight Time (MDT) on Jan. 25, 2021

# Submitting sample invoice calculations

- Enbridge Gas wants to ensure the costs of the proposed services are clearly understood
  - Submit two sample invoice calculations for each bid:
    - 1 injection month
    - 1 withdrawal month
  - Sample calculations should be provided in a separate document and not in the bid template
