**Invitation to Bid -
Enbridge Gas Inc. New Capacity Open Season M12,
M12X, or M17 Transportation Services**

Enbridge Gas Inc. (“**Enbridge Gas**”) is pleased to announce a new capacity, non-binding open season for firm M12*, M12X* or M17* transportation service (the “**2029/2030 Open Season**”) for up to a total of 300,000 GJ/day of capacity proposed to begin Nov. 1, 2029/2030 for a minimum twenty (20) year term for the following transportation paths:

- (a) Dawn (Facilities) to Parkway
- (b) Kirkwall to Parkway
- (c) Dawn to Kirkwall
- (d) Dawn to Dornoch

Dawn (Facilities) to Parkway/ Kirkwall to Parkway M12, M12X, or M17 Firm Transportation Service
Total Capacity Available: up to 300,0000 GJ/d

*Enbridge Gas has proposed to harmonize rates in Phase 3 of the Rebasing proceeding (EB-2025-0064).

The purpose of the 2029/2030 Open Season is to allow Enbridge Gas to evaluate the new facility design requirements to support market needs. Based on the results of the 2029/2030 Open Season, Enbridge Gas will determine whether or not to proceed with offering the services as defined in the 2029/2030 Open Season.

All bids are due on or before 2 p.m. ET/ 1 p.m. CT, on April 10, 2026. Enbridge Gas expects to inform successful bidders of their awarded capacity on or before 4 p.m. ET/ 3 p.m. CT on April 17, 2026. Enbridge Gas reserves the right to reject any and all bids at its sole discretion.

Submitting a Bid for Transportation Service and Awarding of Capacity

Enbridge Gas, at its sole discretion, reserves the right to reject any and all bid proposals received, terminate the 2029/2030 Open Season, or modify or extend the 2029/2030 Open Season or related documents.

All capacity requests that meet the respective service parameters during this 2029/2030 Open Season will be awarded as per Enbridge Gas's Allocation Procedures in Section XVI of the Enbridge Gas M12 tariff [General Terms and Conditions](#), starting with those bids with the highest economic value. If the economic values of two or more independent bids are equal, then transportation service shall be allocated on a pro-rata basis, if needed. The economic value shall be based on the net present value which shall be calculated based on the proposed per unit rate and the proposed term of the contract and without regard to the proposed contract demand.

Any suggested conditions precedent proposed by the bidder should be clearly articulated and attached to the bid form and will be considered during the capacity allocation process. Successful bidders will be expected to enter into a definitive **Precedent Agreement** with Enbridge Gas by September 1, 2026.

A **Financial Backstopping Agreement** may also be required. The need for such an agreement will be determined by the facilities required to provide the transportation service requested by the bidders. Enbridge Gas may request OEB approval for a term-up provision for shippers who currently hold easterly flow service from Dawn (Facilities) or Kirkwall to Parkway as part of any regulatory filing for the construction of new facilities. The term-up provision would require the shipper to extend the term of their current contract for 5 years after the in-service date of any new facilities.

About the Enbridge Gas Dawn Hub

The Enbridge Gas Dawn Hub is the largest integrated natural gas storage facility in Canada and one of the largest in North America. It offers customers, such as power generators, distribution and pipeline companies and energy marketers, an important link in the movement of natural gas from key supply basins to markets in central Canada and the northeast U.S.

- A working storage capacity of 290 Bcf.
- Bi-directional service.
- Takeaway capacity of 7.6 Bcf a day.
- Daily demand at Dawn from markets in Ontario, Quebec, the U.S. Midwest and the U.S. Northeast.
- Interconnects with several major pipelines including Vector, Great Lakes, Panhandle, Bluewater, MichCon and TransCanada at Kirkwall and at Parkway.
