(a) Includes base rate of \$0.3875 for the first 50 Mcf and \$1.2282 for over 50 Mcf, Interim Emergency and Temporary PIP Plan Rider of \$0.1515/Mcf, Uncollectible Expense Rider of \$0.1865/Mcf, Operational Balancing Rider of \$0.4061/Mcf, Surcredit Rider of (\$0.0008)/Mcf, Demand Side Management Rider of \$0.0149/Mcf, and Excise Tax Rider of \$0.1593/Mcf for the first 100 Mcf, \$0.0877/Mcf for the next 1,900 Mcf, and \$0.0411/Mcf for all volumes over 2,000 Mcf.

(b) In addition to the above rates, gross receipts tax will be charged at 4.9800% on the total EGO charges.

(c) Beginning in November 2025, customers may be charged a late payment charge (LPC) of 1.5% if the current month's charges are not paid in full by the time the next bill is generated. For Payment Plan and Budget customers, the LPC applies only to the past-due plan amount.

Notes: The minimum monthly charge for each location shall be the Basic Service Charge.
