NR customers with annual usage of 200 Mcf or less, as determined by EGO, will default to the SCO if they don't choose a retail supplier or aggregation program, or they can elect to be placed on SCO.

NR customers with annual usage of greater than 200 Mcf and up to 500 Mcf, as determined by EGO, will default to the MRR (Monthly Retail Rate) if they don't choose a retail supplier or aggregation program, or they can elect to be placed on SCO.

NR customers with annual usage of greater than 500 Mcf, as determined by EGO, will default to the MRR (Monthly Retail Rate) if they don't choose a retail supplier or aggregation program; they are not eligible for the SCO.
