Natural gas rates have changed

New natural gas rates

The Ontario Energy Board (OEB) has approved changes to the rates Enbridge Gas charges its customers effective **Oct. 1, 2025**.

A typical commercial and industrial customer will see an annual decrease of 6.2 percent. The total impact on your bill will depend on how much gas you use.

Delivery to You

The delivery charges that vary with consumption decreased based on our forecast cost of delivering natural gas to your home or business. These charges include a facility carbon charge associated with the operation of Enbridge Gas' facilities to deliver natural gas to you. The delivery charges on your bill also include a charge for the 2024 rate adjustment. Details for this rate adjustment can be found in the rate adjustment section below.

Transportation to Enbridge

The transportation charge has decreased by approximately \$12.73 per year for a typical customer due to lower costs for transporting natural gas to Ontario. The transportation charge includes a charge for the 2024 rate adjustment. Details for this rate adjustment can be found in the rate adjustment section below.

Gas Supply Commodity Charge

The gas supply commodity charge has decreased from 13.4419 ¢/m³ to 12.4430 ¢/m³ based on our forecast of natural gas market prices for the next 12 months. The gas supply commodity charge includes a charge for the 2024 rate adjustment. Details for this rate adjustment can be found in the rate adjustment section below.

Cost Adjustment

The current adjustment is a refund of 2.7596 ¢/m³. The cost adjustment reflects the true-up between actual and forecast prices for prior periods. Please see the included chart for the breakdown by component.

Rate Adjustment

This rate adjustment reflects changes to Enbridge Gas' 2024 rates to recover the revenue variance between the approved effective date of Jan. 1, 2024 and the implementation date of Jan. 1, 2025. The adjustment will continue to be applied from Jan. 1, 2025 to Dec. 31, 2025 and is included in the Delivery to You, Transportation to Enbridge and Gas Supply Commodity sections. The total impact on your bill will depend on your usage.

Charges for gas used from Oct. 1, 2025 will be calculated using the new approved rates as shown in the chart. The annualized impact is based on a typical Rate 10 - Union North West customer who uses 93,000 cubic metres (m³) per year.
