# Natural gas rates have changed

# New natural gas rates

The Ontario Energy Board (OEB) has approved changes to the rates Enbridge Gas charges its customers effective **July 1, 2025**.

The total impact on your bill will depend on how much gas you use and the terms of your gas marketer agreement.

### **Delivery to You**

The delivery charges that vary with consumption decreased based on our forecast cost of delivering natural gas to your home or business. These charges include a facility carbon charge associated with the operation of Enbridge Gas' facilities to deliver natural gas to you. The facility carbon charge has decreased from 0.0172 cents per cubic metre (¢/m³) to 0.0123 ¢/m³. The delivery charges on your bill also include a charge for the 2024 rate adjustment as approved by the OEB. Details for this rate adjustment can be found in the rate adjustment section below.

## **Federal Carbon Charge**

The federal carbon charge was removed from customer bills effective April 1, 2025. Please note that your bill will show federal carbon charges incurred for any gas usage up to and including March 31, 2025.

#### **Gas Supply Commodity Charge**

The price you pay for the natural gas you use, shown as the gas supply charge on your bill, depends on the terms of your gas marketer agreement.

### **Rate Adjustments**

The OEB has approved a rate adjustment to reflect the difference between the amount customers paid for the energy conservation programs (DSM) from Jan. 1 to Dec. 31, 2022 and the actual costs incurred. On July bills, this will appear as a one-time refund of approximately \$369.60 for a typical customer.

The OEB-approved rate adjustment to reflect changes to Enbridge Gas' 2024 rates to recover the revenue variance between the approved effective date of Jan. 1, 2024 and the implementation date of Jan. 1, 2025, will continue to be applied from Jan. 1, 2025 to Dec. 31, 2025. Please see the included chart for breakdown by component. The total impact on your bill will depend on your usage and your arrangement with your gas marketer.

Charges for gas used from July 1, 2025 will be calculated using the new approved rates as shown in the chart. The annualized impact is based on a typical Rate M2 - Union South customer who uses 73,000 cubic metres (m³) per year while buying gas from an energy marketer.
