

## **BUNDLED DIRECT PURCHASE SCHEDULE – UNION RATE ZONES**

This Schedule is made between Enbridge Gas Inc. (the “Company”) and the Customer or Agent set out above and forms part of the Contract between the Parties for the Service(s) set out herein.

### **1. BUNDLED DIRECT PURCHASE SERVICE CONTRACT**

- (a) Direct Purchase: Under this Schedule, the Company will receive quantities of Gas from the Customer or Agent and deliver Gas to End Use Customer(s) in accordance with the applicable Rate Schedule(s). This Schedule replaces any previous Bundled Direct Purchase Service Schedules, subject to the settlement of any surviving obligations.
- (b) General Terms and Conditions: The Company’s General Terms and Conditions applicable to Distribution and Direct Purchase Services posted on the Company’s website, together with those additional documents listed in Section 1.1 of the General Terms and Conditions, are incorporated into and form part of this Schedule. Capitalized terms used in this Schedule and not defined herein have the meanings given to them in the General Terms and Conditions. For the purposes of this Schedule, “Customer” means all End Use Customers associated with the Customer or Agent named above on a Company Platform in respect of a Gas Pool.
- (c) Other Services: If the Customer or Agent requires distributor consolidated billing services from the Company, a service agreement must be entered into with the Company.
- (d) Access to Company Platform: This Schedule must be executed by the Parties prior to the Customer or Agent being provided access to a Company Platform for the purposes of creating Gas Pools.
- (e) Financial Assurances: This Schedule and the rights and obligations of the Parties herein are conditional upon the Customer’s or Agent’s provision and continuing maintenance of Financial Assurances acceptable to the Company in accordance with the General Terms and Conditions. Financial Assurances must initially be provided by the Customer or Agent prior to the Service Start Date.
