This Schedule is made between the customer set out above (“Customer”) and Enbridge Gas Inc. (“Company”) and forms part of the Contract between the Parties for the Service(s) set out herein.

1. GAS DISTRIBUTION SERVICE CONTRACT

- (a) *Distribution Service:* Under this Schedule the Company will distribute Gas to the Customer’s Point(s) of Consumption pursuant to the Rate Schedule(s) identified herein. This Schedule replaces any previous Distribution Service Schedules for the Point(s) of Consumption set out herein, subject to the settlement of any surviving obligations.
- (b) *General Terms and Conditions:* The Company’s General Terms and Conditions applicable to Distribution and Direct Purchase Services posted on the Company’s website, together with those additional documents listed in Section 1.1 of the General Terms and Conditions, are incorporated into and form part of this Schedule. Capitalized terms used in this Schedule and not defined herein have the meanings given to them in the General Terms and Conditions.
- (c) *Direct Purchase:* If Customer has elected bundled Direct Purchase Services for the supply of Gas to be delivered, Customer and the Company will execute a Direct Purchase Service Schedule.
- (d) *Financial Assurances:* This Schedule and the rights and obligations of the Parties herein are conditional upon the Customer’s provision and continuing maintenance of Financial Assurances acceptable to the Company in accordance with the General Terms and Conditions. Financial Assurances must initially be provided by the Customer prior to the Service Start Date.
- (e) *Interruptible Service Conditions:* If Customer has contracted for Interruptible Service under this Schedule, Customer acknowledges and agrees that Customer is required to comply with Section 14 (Interruptible Service) of the General Terms and Conditions, including the requirement that Customer comply with any Interruption direction given by the Company, failing which the Company may exercise its remedies under the Contract, up to and including suspension or termination.

(c) **M4 / M5 Additional Terms:**
