## Natural Gas Prices Have Changed

The Ontario Energy Board (OEB) has approved changes to the rates Enbridge Gas charges its customers effective **Oct. 1, 2025**.

On average, these changes will amount to a decrease of approximately 6.2 percent annually. The total impact on your bill will depend on how much gas your organization uses.

Your current bill has been calculated using the new approved rates for gas consumed from Oct. 1, 2025. The rate chart is included in this notice.

Our supply prices are based on a forecast of market prices for the next 12 months. The forecasted prices are reviewed every three months and adjusted accordingly. If our forecasts are over or under our actual costs, the difference is refunded or collected from customers through cost adjustments.

## Delivery to You

The delivery rates that vary with consumption decreased based on our forecast cost of delivering natural gas to your business. These charges include a facility carbon charge associated with the operation of Enbridge Gas' facilities to deliver natural gas to you. The delivery rates on your bill also include a charge for the 2024 rate adjustment. Details for this rate adjustment can be found in the rate adjustment section below.

## Load Balancing Charge

The load balancing charge has decreased due to lower seasonal load balancing related costs.

## Transportation to Enbridge

The 'Transportation to Enbridge' charge has decreased due to lower costs for transporting natural gas to Ontario. The transportation charge also includes a charge for the 2024 rate adjustment. Details for this rate adjustment can be found in the rate adjustment section below.

## Gas Supply Commodity Charge

The gas supply commodity charge has decreased from 12.9955 cents per metre (¢/m<sup>3</sup>) to 12.2351 ¢/m<sup>3</sup> based on our forecast of natural gas market prices for the next 12 months. The gas supply commodity charge also includes a charge for the 2024 rate adjustment. Details for this rate adjustment can be found in the rate adjustment section below.

Enbridge Gas does not make a profit on the price of natural gas.

## Cost Adjustment

The current adjustment is a refund of 2.0432 ¢/m<sup>3</sup>. Please see the included chart for the breakdown by component.

Rate Adjustment

This rate adjustment reflects the changes to Enbridge Gas’ 2024 rates for the period of Jan. 1, 2024 to Dec. 31, 2024. The adjustment will continue be applied to customers bills from Jan. 1, 2025 to Dec. 31, 2025.

The adjustment is included in each component of your bill, if applicable:

Gas Supply Transportation Charge	0.0002 ¢/m³

Notes:

\* The total effective gas supply rate shown on your bill is 9.8435 ¢/m³. The rate is the sum of the gas supply commodity charge of 12.2351 ¢/m³, the gas cost adjustment of (2.3917) ¢/m³, and the rate adjustment gas supply commodity charge of 0.0001 ¢/m³. The total effective gas supply charge has decreased since the last rate change.
