Contest Rules & Regulations ('Contest Rules')

CONTEST: Three (3) PRIZES comprised of \$200 gift cards.

WHO CAN ENTER: This Contest is open to property owners in the Bobcaygeon community who are at least 18 years old at the time of entry. **Only one entry per household is permitted.** Employees of Enbridge Gas, its subsidiaries and affiliated companies and each of their respective directors, officers, employees, agents, representatives, advertising or promotional agencies, members of their immediate families and persons with whom any of the foregoing are domiciled are not eligible.

CONTEST PERIOD: The Contest starts on September 26, 2025, and closes on December 18, 2025 at 11:59 am EST (the **'Close Date'**). The period in which the Contest is open to entrants from September 26, 2025, until the Close Date is referred to as the **'Contest Period**'.

PRIZES: There are three (3) prizes to be won, comprised of \$200 (two hundred dollar) gift cards. All entries must be received by 11:59 am EST on December 18, 2025 to be eligible for the Prize draw.
