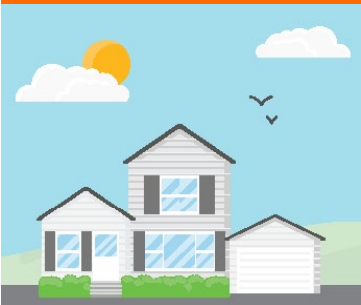

Natural gas rates have changed

New natural gas rates

The Ontario Energy Board (OEB) has approved changes to the rates Enbridge Gas charges its customers effective **July 1, 2026**.

For a typical customer the total annual bill increase will be \$8.87. The total impact on your bill will depend on how much gas you use.

Delivery to You

The delivery charges that vary with consumption decreased based on our forecast cost of delivering natural gas to your home or business. These charges include a facility carbon charge associated with the operation of Enbridge Gas’ facilities to deliver natural gas to you.

Gas Supply Commodity Charge

The gas supply commodity charge has decreased from 17.6410 ¢/m³ to 16.1833 ¢/m³ based on our forecast of natural gas market prices for the next 12 months.

Cost Adjustment

The current adjustment is a charge of 1.2038 ¢/m³. The cost adjustment accounts for the variance between actual and forecast prices from earlier periods. Please see the included chart for the breakdown by component.

Rate Adjustment

This rate adjustment reflects the difference between the amount customers paid for the energy conservation programs (DSM) from Jan. 1 to Dec. 31, 2023 and the actual costs incurred. This will appear on customers’ July bills as a one-time charge of approximately \$3.58 for a typical customer.

Charges for gas used from July 1, 2026 will be calculated using the new approved rates as shown in the chart. The annualized impact is based on a typical Rate M1 - Union South customer who uses 2,200 cubic metres (m³) per year.

* The total effective gas supply rate shown on your bill is 17.3871 ¢/m³. This rate is the sum of the gas supply commodity charge of 16.1833 ¢/m³ and the gas cost adjustment of 1.2038 ¢/m³. The total effective gas supply charge has increased since the last rate change.
