CONTEST OBJECTIVE: The Contest offers participants the chance to win one (1) of twenty one (21) prizes, each consisting of a \$1,000 gift card.

WHO CAN ENTER: This Contest is open to all residential customers of Enbridge Gas Inc. ("Enbridge Gas") with an active Enbridge Gas account, who are at least 19 years of age, and who switch to paperless billing between June 17, 2026 and December 31, 2026 and remain on paperless billing ("eBilling") on the date of the draw, residing in Utah, Wyoming and Idaho. Only one entry per household is permitted. Please note that employees of Enbridge Gas, its subsidiaries and affiliated companies and each of their respective directors, officers, employees, agents, representatives, advertising or promotional agencies, members of their immediate families and persons with whom any of the foregoing are domiciled are not eligible to participate in this Contest.

CONTEST PERIOD: The Contest starts on June 17, 2026 and closes on December 31, 2026 at 11:59 pm EDT (the 'Close Date'). The period in which the Contest is open to entrants from June 17, 2026 until the Close Date is referred to as the 'Contest Period'.

HOW TO ENTER: NO PURCHASE NECESSARY. To enter the Contest, eligible participants will be automatically entered into the random draw when they switch to eBilling between June 17, 2026 and December 31, 2026 and remain on eBilling on the date of the draw. No additional steps are required to enter.

To remain eligible, entrants must continue to be enrolled on eBilling on the applicable draw date. Entrants who are no longer enrolled in eBilling or switch to paper billing at the time of the draw date will be disqualified and their entries will be void. Entrants who have previously won a prize in any prior Grocery Gift Card Giveaway are not eligible to win again during the applicable draw. Monthly draw dates will be held on July 1, August 1, September 1, October 1, November 1, December 1 and January 1 (collectively the 'Draw Dates' and individually a 'Draw Date' as applicable).
