

OFFICIAL CONTEST RULES AND REGULATIONS

eBill monthly Contest: Win a \$1,000 Gift Card by Enbridge Gas.

Contest Rules & Regulations (“Contest Rules”)

August 11, 2026 to February 17, 2027

CONTEST: The Contest offers participants the chance to win one (1) of twenty one (21) prizes, each consisting of a \$1,000 gift card.

WHO CAN ENTER: This Contest is open to all residential customers of Enbridge Gas Inc. (“**Enbridge Gas**”) with an active Enbridge Gas account, who are at least 19 years of age, residing in Utah, Wyoming and Idaho. **Only one (1) entry per household is permitted.** Please note that employees of Enbridge Gas, its subsidiaries and affiliated companies and each of their respective directors, officers, employees, agents, representatives, advertising or promotional agencies, members of their immediate families and persons with whom any of the foregoing are domiciled are not eligible to participate in this Contest.

CONTEST PERIOD: The Contest starts on August 11, 2026 and closes on February 17, 2027 at 11:59 pm MDT (the “**Close Date**”). The period in which the Contest is open to entrants from August 11, 2026 until the Close Date is referred to as the “**Contest Period**”.

HOW TO ENTER: NO PURCHASE NECESSARY. To enter the Contest, eligible participants may enter through one of the following methods:

- Existing residential customers enrolled in eBilling as of the applicable Draw Date will automatically receive one (1) entry.
- Residential customers who enroll in eBilling during the Contest Period will automatically receive one (1) entry.
- Residential customers who are not enrolled in eBilling, or do not wish to enroll in eBilling, may enter through the Alternative Method of Entry described below.

Limit one (1) entry per household during the Contest Period, regardless of method of entry.

Enrollment in eBilling is not required to enter or win and will not increase the odds of winning. Entrants who have previously won a prize in any prior Gift Card Giveaway are not eligible to win again during the applicable draw. Monthly draw dates will be held on August 20, September 21, October 20, November 20, December 18, January 20 and February 24 (collectively the “**Draw Dates**” and individually a “**Draw Date**” as applicable).

Participants can enter by:

Alternate Method of Entry (“AMOE”): To enter the Contest without performing an online transaction, you may enter by mail as follows: On a plain 3” x 5” card, legibly handprint or type your first name, last name, complete address, city, state, zip code, home phone number (including area code) date of birth, and email address (if any) and mail your completed 3” x 5” card to: “Enbridge eBill Contest”, PO Box 45360, SLC UT 84145. Each envelope shall equal one (1) entry. Limit of one (1) entry by mail per household during the Contest Period. Entries must be postmarked by February 17, 2027 and received by February 19, 2027. Multiple entries submitted by a single entrant, household, or in the same envelope are void. Entries submitted or completed by anyone other than the entrant are void. No mechanical reproductions will be accepted. Enbridge Gas will not verify receipt of entries for entrants. All entries submitted become the sole

property of Enbridge Gas and will not be returned. Void where prohibited. Enbridge Gas is not responsible for lost, late, misdirected, illegible, damaged or postage-due AMOE Entries. By submitting an AMOE card you agree to be bound by these Contest Rules. Consult applicable laws for additional eligibility or registration requirements.

Enbridge is not responsible for lost, late, damaged, illegible, stolen, misdirected, misidentified or incomplete entries, for any problems or technical or mechanical malfunction of any telephone systems, computer on-line systems, servers, access providers, computer equipment, software, failure of any entry to be received by Enbridge on account of technical problems or traffic congestion on the Internet or at any website, or inaccurate entry information, whether caused by equipment, programming used in this Contest, human processing or otherwise, or any combination thereof.

PRIZES: A total of twenty-one (21) prizes are available to be won. Each prize consists of one (1) gift card ("Gift Card") valued at one thousand United States of America dollars (USD \$1,000). At the time of the draw, 2 (two) additional names, will be drawn in the case the selected entrant has failed to comply with the eligible requirements. The Gift Card prize will be a gift card sent to the winner's residential account address by courier.

Prizes are non-transferable and non-assignable. No substitution of prizes is permitted except by Enbridge Gas. All prizes will be awarded. The odds of winning are dependent upon the number of eligible entries received by the applicable Draw Date.

RANDOM DRAW: A total of twenty-one (21) names will be selected, three on each of the Draw Dates, in a random draw on the specified dates from among all eligible entries received for the Contest during the Contest Period by the applicable Draw Date. Enbridge Gas reserves the right to require proof of age and jurisdiction of residence prior to awarding any Gift Card prize. Enbridge will also draw two additional names on each of the Draw Dates solely for use in case the previous selected entrant for such Draw Date is ineligible to win the Gift Card prize.

No Customer Preference/Equal Treatment. Enbridge Gas will not offer any preference, advantage, or benefit to one customer or class of customers over another in connection with this Contest. All eligible entries will be treated equally regardless of account history, service level, enrollment status, or any similar factor. Winners will be selected and verified based solely on the criteria set forth in these Contest Rules, and Enbridge Gas will not use customer status, account history, service level, or any similar factor to prioritize, weight, or otherwise influence entries or the awarding of prizes. Void where prohibited. This provision controls to the extent of any inconsistency with other rules.

WINNER NOTIFICATION: Selected entrants will be notified by email using the account holder's Enbridge Gas billing e-mail address) or phone within 48 hours of the Draw Date. To be declared a winner, a selected entrant must:

- 1) Acknowledge eligibility for the Gift Card by telephone or email;
- 2) Sign and return an Affidavit and Release Form to Enbridge Gas email id: marketing_contest_mailbox@enbridge.com marketing within ten (10) business days of the date on which the notification is sent to the selected entrant for signing. If no response is received by Enbridge within ten (10) business days of the date on which the notification is sent, the Gift Card Prize will be forfeited and may be awarded to an alternate selected entrant in a random draw that has been drawn from the remaining eligible entries for that Draw Date; and
- 3) Winners may also be asked to provide contact and identity information for verification only. Such verification will not include, nor be used to confer, any preference based on customer status.

GENERAL: Enbridge Gas is not responsible for any costs associated with claiming the Gift Card prize. Winners are solely responsible for the reporting and payment of any and all taxes, if any, that may result in winning a Prize in this Contest.

Decisions of Enbridge Gas are final on all matters of fact, interpretation, eligibility, procedure and fulfillment in respect to this Contest. Enbridge Gas reserves the right at any time to withdraw this Contest or to modify, amend, or supplement these rules, in its sole discretion, subject to applicable law.

By participating in this Contest, the winners consent to the use by Enbridge Gas of their name, hometown and photograph for any lawful purpose, without further permission or compensation, except where prohibited by law. The winners agree to abide by and be bound by these Contest Rules.

Any personal information collected during an individual's participation in the Contest, will be collected and used by Enbridge Gas for the purposes of the proper administration and fulfillment of the Contest as described in these Contest Rules and for the purpose of paperless billing and will not be shared with any third party except as required by law, or to conform with legal process or to protect or defend the legal rights or property of Enbridge.

Enbridge Gas, their subsidiaries and affiliated companies and each of their respective directors, officers, employees, agents, representatives, advertising, promotion, and fulfillment agencies, and legal advisors are not responsible for and shall not be liable for: (i) telephone, electronic, hardware or software program, network, internet, or computer malfunctions, failures, or difficulties of any kind; (ii) failed, incomplete, garbled, or delayed computer transmissions; (iii) any condition caused by events beyond the control of Enbridge Gas, that may cause this Contest to be disrupted or corrupted; (iv) any injuries, losses, or damages of any kind arising in connection with or as a result of the prize, or acceptance, possession, or use of the prize, or from participation in this Contest; or (v) any printing or typographical errors in any materials associated with this Contest.
