Natural Gas Prices Have Changed

The Ontario Energy Board (OEB) has approved changes to the rates that Enbridge Gas charges its customers effective Jan. 1, 2024. The new interim rates will be charged beginning on **May 1, 2024**. On average, these changes will amount to a decrease of approximately 33.5 percent annually. The total impact on your bill will depend on how much gas your organization uses and the terms of your gas marketer agreement.

The price you pay for the natural gas you use, shown as the Gas Supply Commodity Charge on your bill, depends on the terms of your agreement with your gas marketer.

Your current bill has been calculated using the new approved rates for gas consumed from May 1, 2024. The rate chart is included in this notice.

Customer Charge

The customer charge increased to \$139.56 a month to partially recover some of the fixed costs associated with maintaining a safe and reliable natural gas distribution system.

Delivery to You

The delivery rates that vary with consumption decreased due to changes to Enbridge Gas' 2024 rates. These charges also include a facility carbon charge associated with the operation of Enbridge Gas' facilities to deliver natural gas to you.

The delivery rates on your bill includes a credit for the clearing of various deferral accounts (Rider D) and a charge for the 2024 rate adjustment (Rider E) as approved by the OEB. Details for these rate adjustments can be found in the rate adjustment section below.

Load Balancing Charge

The load balancing charge has decreased due to changes to Enbridge Gas' 2024 rates.

Transportation to Enbridge

A 'Transportation to Enbridge' charge will appear in the top Enbridge section of your gas charges.

If Enbridge Gas provides transportation service from Western Canada and the United States to our distribution system in Ontario, the transportation to Enbridge charge has increased due to changes in Enbridge Gas' 2024 rates.

If Enbridge Gas provides transportation service from the Dawn market hub in southwestern Ontario to our distribution system, the rate has increased to 0.9400 ¢/m³. In this case, your marketer either provides transportation service for your gas supply to the Dawn market hub or purchases gas supply at the Dawn market hub. The rate you pay for transportation and/or gas supply from you marketer is based on the terms of your gas marketer agreement and these charges will appear in the marketer section of your gas charges.

The transportation charge includes a charge for the 2024 rate adjustment (Rider E) as approved by the OEB. Details for this rate adjustment can by found in the rate adjustment section below.

If your transportation service is provided by your marketer

Your 'Transportation to Enbridge' charge will appear with your marketer charges on your bill. The rate you pay for transportation is based on the terms of your gas marketer agreement.

Federal Carbon Charge

The federal carbon charge is 15.25 ¢/m³. This charge increases annually each April. All of the money collected for this charge goes to the government. Some businesses may be eligible for full or partial exemption from this charge under the federal carbon pricing program.

Cost Adjustment

The current cost adjustment includes a refund of 0.0746 ¢/m³ for load balancing and a charge of 0.1989 ¢/m³ for transportation. The cost adjustment is in effect until March 31, 2025.

Our supply prices are based on a forecast of market prices for the next 12 months. The forecasted prices are reviewed every three months and adjusted accordingly. If our forecasts are over or under our actual costs, the difference is refunded or collected from customers through cost adjustments.

Rate Adjustment

The OEB has approved a Rider E rate adjustment to reflect the changes to Enbridge Gas' 2024 rates for the period of Jan. 1, 2024 to April 30, 2024. These adjustments will be applied to customers bills from May 1, 2024 to Dec. 31, 2024. The following adjustments will be included in each component of your bill, if applicable:

Delivery Charge - Contract Demand 0.1277 ¢/m³
Delivery Charge - Commodity (3.2209) ¢/m³
Gas Supply Transportation Charge 0.0024 ¢/m³
Gas Supply Transportation Dawn Charge 0.0148 ¢/m³
Gas Supply Commodity Charge 0.0017 ¢/m³

The total impact on your bill will depend on how much your organization uses.

The OEB has also approved a Rider D rate adjustment to reflect the clearance of various deferral and variance account balances. This is a credit of 4.4431 ¢/m³/day that will appear on customers bills from May 1, 2024 to Dec. 31, 2024. The total impact on your bill will depend how much gas your organization uses.
