# Natural gas rates have changed

# New natural gas rates

The Ontario Energy Board (OEB) has approved changes to Enbridge Gas' rates effective Jan. 1, 2024.

For a typical customer the total annual bill decrease will be \$7.22. The total impact on your bill will depend on how much gas you use and the terms of your gas marketer agreement.

## **Delivery to You**

The delivery rates that vary with consumption decreased based on our forecast cost of delivering natural gas to your home or business. These charges also include a facility carbon charge associated with the operation of Enbridge Gas' facilities to deliver natural gas to you. The facility carbon charge has decreased from 0.0162 cents per cubic meter (¢/m³) to 0.0157 ¢/m³.

### **Transportation to Enbridge**

The transportation charge has decreased by approximately \$6.66 per year for a typical customer due to lower costs for transporting natural gas to Ontario.

## **Federal Carbon Charge**

The federal carbon charge is 12.39 ¢/m³. This charge increases annually each April. All of the money collected for this charge goes to the government.

### **Gas Supply Charge**

The price you pay for the natural gas you use, shown as the gas supply charge on your bill, depends on the terms of your gas marketer agreement.

#### **Cost Adjustment**

The current adjustment is a charge of 0.4279 ¢/m³. The cost adjustment reflects the true-up between actual and forecast prices for prior periods. Please see the included chart for the breakdown by component.

Charges for gas used from Jan. 1, 2024 will be calculated using the new approved rates as shown in the chart. The annualized impact is based on a typical Rate 01 - Union North West customer who uses 2,200 cubic metres (m³) per year while buying gas from an energy marketer.
